WE BELIEVE THE MAKEUP OF OUR BOARD ENSURES THERE ARE QUALIFIED INDIVIDUALS FAMILIAR WITH THE ORGANIZATION AND PROCESS TO ACCEPT RESPONSIBILITY FOR THE PREPARATION OF THE 990.
